International project management

Adetef and Ministries have earned widespread recognition for their ability to prepare and manage projects. They have overseen more than 120 European Union twinning arrangements and taken part in an increasing number of tendered projects funded by international donors. The administrative and financial department of Adetef shares its expertise in twinning and contract management with other administrations.

Our activities

Adetef provides various types of assistance, including consulting and audits, seminars, study visits and symposiums, as well as evaluations.

Bilateral co-operation / At the request of partner administrations, the Ministries' Directorates and Adetef also take on short or medium-term assignments within the framework of ad hoc technical assistance agreements. Funding is either provided by France or by the beneficiary country.

European Union institutional twinings / The European Union finances 6 to 24 month twinning projects, for which EU member States' agencies present bids.

Multilaterally-funded programmes / In consortium with other technical assistance stakeholders, Adetef and the Ministries' Directorates leverage their network of experts to respond to calls for tender issued by international organisations such as the World Bank, regional development banks (Asian Development Bank and African Development Bank), and the European Union.
